DOMESTIC ADOPTION FEE SCHEDULE

FORMAL APPLICATION:

Due with submission of formal application \$ 550

HOMESTUDY:

Due at the first interview of the homestudy \$ 1,500
 (Returning Bethany families will receive a 25% discount off their homestudy for a total fee of \$1,125)

ADOPTION SERVICES:

Adoption Services \$ 3,650

Due at the final visit of the homestudy. Includes selection and matching services, case management prior to placement, and communication before placement.

Adoption Placement \$ 11,000

Due at placement. Includes birth parent counseling, cradle (interim foster) care, case management and office support services. In the event of twins, there is an additional fee of \$4000. Bethany will reduce \$1,000 of the fee due at adoptive placement if a match occurs through networking.

POST PLACEMENT:

Due at placement. Post placement supervision reports and Court report preparation. \$ 1,500

TOTAL AGENCY FEES (excluding variable costs) \$ 18,200

VARIABLE COSTS:

Birthparent TPR (termination of parental rights) **Actual Cost**

Legal work to complete termination of parental rights (including private investigator, constable, and advertising if required). Payable directly to attorney.

Adoption Finalization **Actual Cost**

Payable directly to attorney

Update of Home Study \$ 500

Based on state guidelines or for any change in family situation, or when state regulations require an update. Payable upon invoice.

Foster Care (if applicable) \$ 25 per day

When requested by the adoptive parents. Paid at placement.

When requested by birthparent. Paid at placement \$ 12
per day

Medical Care **Actual Cost**

Medical expenses for birth mother and child when other medical coverage is not available.

*All fees are non-refundable. The fee due at placement will be returned to the adoptive family in its entirety in the event of a disruption.

FORMAL APPLICATION: Due with submission of formal application	\$ 550
HOMESTUDY: Due at the first Homestudy Interview	\$ 1,800
POST PLACEMENT SUPERVISORY VISITS: Retainer due in full upon receipt of invoice and prior to first post placement visit.	\$ 500 per visit
ADDITIONAL COSTS:	
Expediting To complete assessment within one month.	\$ 500
Homestudy Update Requires one home visit because family moved or family composition changed. Due upon receipt of invoice.	\$ 500
Homestudy Update Homestudy must be updated because of job change or financial change; Does not require a home visit. Due upon receipt of invoice.	\$ 300
Homestudy Update Original Homestudy expired; and/or is being used for a new adoption process. Due at the first Homestudy interview.	\$ 1,200
